- 2. Client and Coach both agree to practice attention to personal boundaries at all times.
  - Client acknowledges and understands that <u>The Pre-Season package</u> is a *non-coaching* program. As such, Rachael will only offer feedback during these sessions if the Client gives consent. Client understands that such feedback will not include coaching techniques as included in The MVP package.
  - Client acknowledges and understands that messaging support between sessions is only permitted between coaching sessions as included in <a href="https://doi.org/10.1007/jhp.2007/jhp
